Minutes of the Meeting

1.0 Welcome and Introductions

The meeting opened with an introduction of those present and a welcome to our Guest Speaker Dr Andy Whitfield

2.1 CCG Update

- Dr. Olive Fairbairn

Olive gave an overview of the current status of the CCG as it continues to work towards Authorisation. All papers have now been submitted . Appointment interviews were now being conducted. They had received several good candidates for the nurse post tobe shared with Surrey Heath and they were interviewing tomorrow.

Olive wanted particularly to thank all those who as responded to her request for feedback on Dementia Care which helped to support he bid for funding.

Olive advised the "Out of Hours" service was going out to tender, which would also support Surrey Heath and Bracknell. All Practices would contribute. A working group would be set up across the 3 CCGs.

2.2 Presentation on Commissioning

- Dr. Andy Whitfield

Dr Andy Whitfield gave an extensive review of the commissioning process and how the CCG was set up. Andy presented a significant number of slides. We have requested a copy of the slide to attach to the minutes for later discussion and review. In sharing the commissioning cycle we were advised of some changes to Maternity care being undertaken by Frimley Park Hospital. In particular Berkshire now moving their Maternity services to Frimley Park along side Surrey and Hampshire. We thank Andy for an interesting and extensive presentation.

3.0 Sub-Group Updates

3.1 Extending PPG Representatives

- Update - Ron Baker / Emma Thompson

Ron responded to his extended remit to try to understand why PPG representative s were consistently missing meetings or failing to respond to calling notices or minutes or even joining / supporting the group.

Ron analysed all the attendance records and spoke to a number of people to get their view. The responses were less than positive. Areas sited were the demographics of the attendees. The confusion between the group strategic role and the PPG local role. The time taken to progress the meetings with 25+ attendees. The perceived lack of a Terms of Reference.

A proposal was put forward for the Chairman to visit some PPGs to explain the Groups role and elicit support.

3.2 Research Committee

- Update - Wolfgang Hamann / Donald Hepburn

Wolfgang Hamann reported on activity of the PEG. As planned, Donald Hepburn collated survey results available on the internet from practices within the NEHFPPG. Seventeen out of 24 surgeries have published surveys. Two types of questionnaires (Survey Monkey and General Practice Assessment) were used.

Questions differed between surveys. The result of this compilation are therefore only qualitative. There is an obvious need to ask identical questions, in order to facilitate quantitative surveys.

The surveys addressed mainly administrative issues, e.g. helpful reception, opening hours, waiting times, general level of satisfaction, ease of making appointments.

Clinical issues focused on people skills of the clinical staff.

WH mentioned a recent survey (not part of Donald's compilation) where there was spontaneous concern by many patients about waiting times and availability of physiotherapy services.

Administrative topics are better be dealt with at the surgery level, whereas clinical questions are more suitably addressed NEHFPPG wide.

3.3 **Induction Pack**

lan presented his updated Induction pack which in principal was accepted. Following Ron's comments on lack of attendance it was agreed that it would be helpful to have an induction briefing for all new group members. It was also agreed that we should ask to attend the Monthly practise managers meeting to encourage a more positive response to supporting our group.
